- Before grant of Formal Recognition, you are required to submit the following:-3.

a) Sanctioned programmes along with annual intake in the institution;

 Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph

Name of faculty members who left or joined during the last quarter;

Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

 Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i) The affidavit with enclosure submitted along with application

The institution shall be free to post additional relevant information, if it so desires.

- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 5. Before issuance of Formal Recognition Order, the institution shall convert Endowment Fund of Rs. Five Lakhs and Reserve Fund of Rs. Seven Lakhs into Joint account in any Scheduled Bank with the Regional Director, Southern Regional Committee, National Council for Teacher Education (Regional Director, SRC, NCTE). FDRs converted into Joint Account shall be submitted.

You are required to comply the above requirements for issuance of Formal Recognition Order under 7(16) Regulations, 2014.

- Further, admissions shall not be made until Formal Recognition Order under Regulations 7(16) of the NCTE(Recognition Norms and Procedure)Regulations, 2014 is issued by the Southern Regional Committee, NCTE and affiliation is obtained from the University/Examining body concerned.
- Reply to the Letter of Intent should be submitted within two months from the date of receipt of this letter.

Reply to LOI received on or before <u>03.03.2016</u> shall only be considered for grant of Formal Recognition for the year 2016-17.
